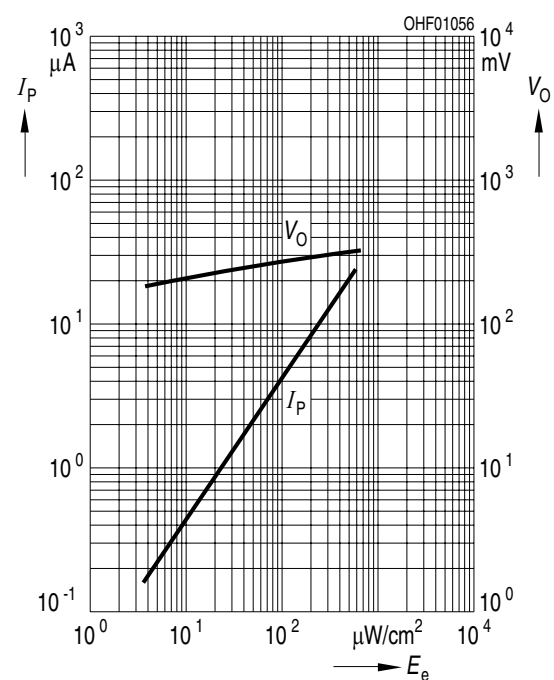

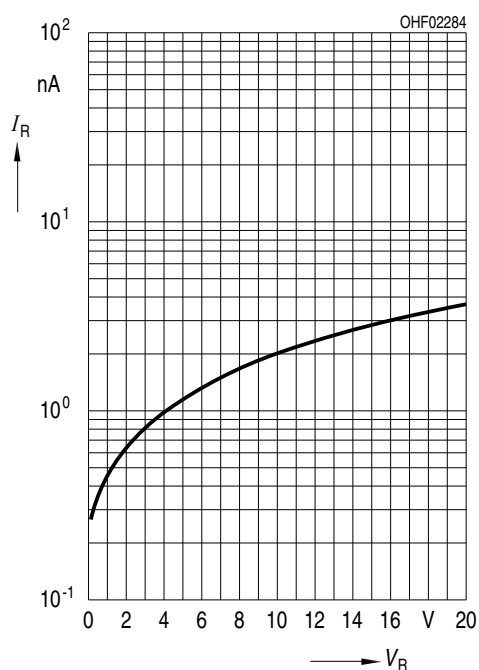

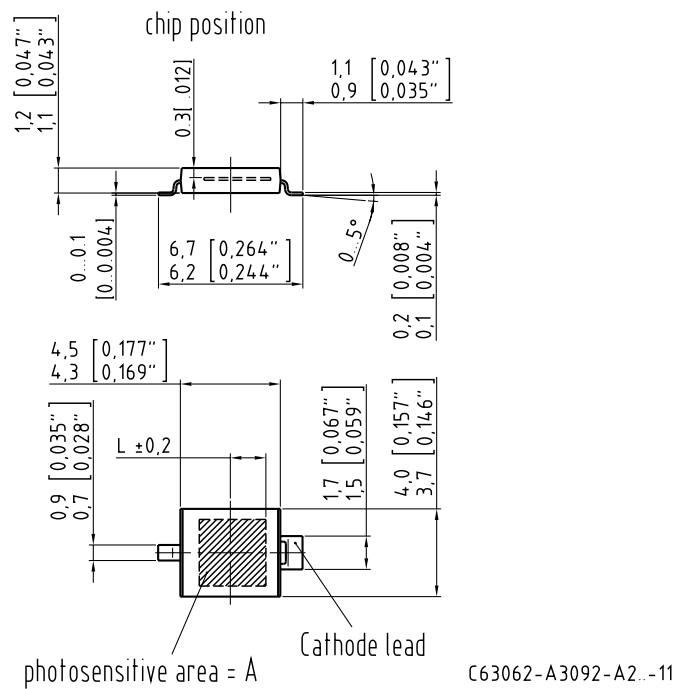


Dark Current ²⁾

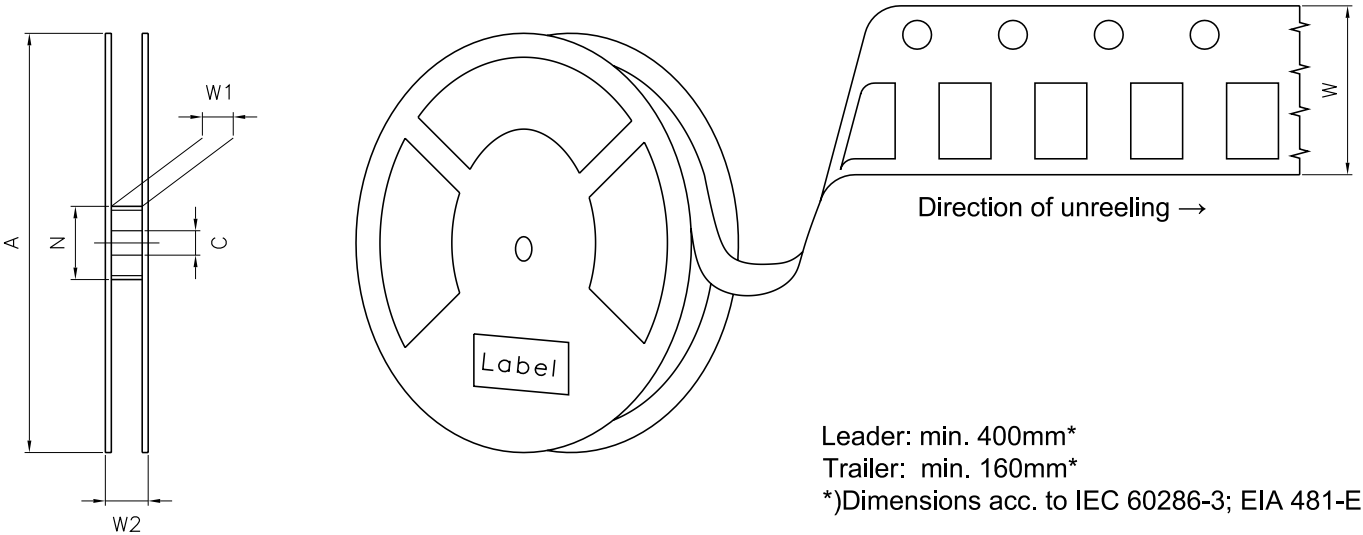

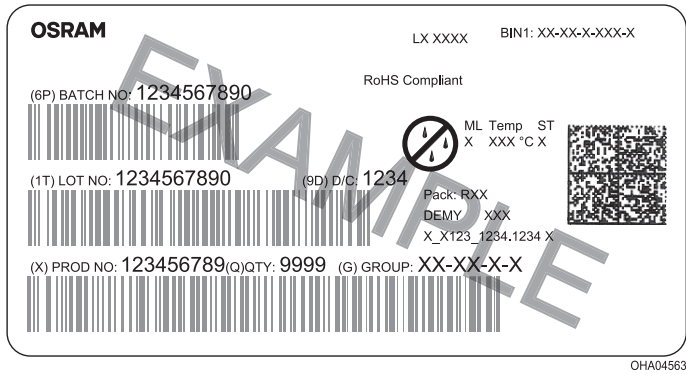

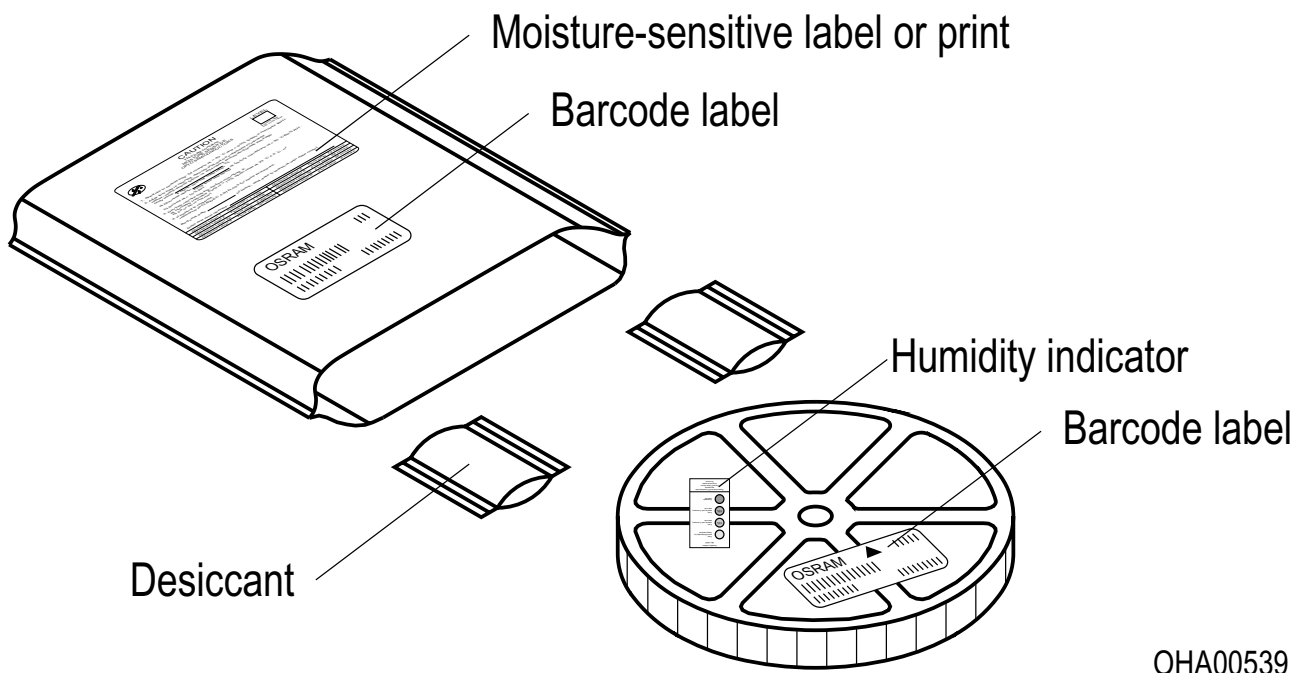
