


## **TPS7B8401EVM Evaluation Module**

This user's guide describes the operational use of the TPS7B8401EVM evaluation module (EVM) as a reference design for engineering demonstration and evaluation of the TPS7B8401 low-dropout (LDO) linear regulator. Included in this user's guide are setup and operating instructions, thermal and layout guidelines, a printed circuit board (PCB) layout, a schematic diagram, and a bill of materials (BOM).

## 1 Introduction

TI's TPS7B8401EVM helps design engineers evaluate the operation and performance of the TPS7B8401 family of linear regulators for possible use in their own circuit application. This particular EVM configuration contains a single wide-input voltage, small size, linear regulator for a wide range of applications. The regulator is capable of delivering up to 150 mA to the load with low  $V_{IN}$  to  $V_{OUT}$  dropout voltage. For stability, use a minimum derated capacitance of 1- $\mu$ F (or larger) output capacitor.

### 1.1 Before You Begin

## 1.2 Inputs/Outputs Connectors and Jumper Descriptions

### 1.2.1 J1 – OUT\_S

Regulated output voltage sense.

### 1.2.2 J2 – OUT

Regulated output power supply voltage screw terminal.

### 1.2.3 J3 – IN

Input voltage banana connector.

### 1.2.4 J4 – IN\_S

Input voltage sense.

### 1.2.5 J5 –IN\_ST

Input supply voltage screw terminal. Twist together the positive input lead and ground return lead from the input power supply, and keep them as short as possible to minimize input inductance.

### 1.2.6 J6 – EN

Output voltage enable. To enable the output voltage, connect the jumper to short VI to EN.

### 1.2.7 J7 – OUT

Regulated output voltage banana connector.

### 1.2.8 J8 – GND

Input supply ground return banana connector.

### 1.2.9 J9 – GND

Regulated output voltage return banana connector.

### 1.2.10 J10 – Setpoint Selection

Use the jumper to short the correct resistor to GND for the desired output voltage.

### 1.2.11 J11 – Test Hookup

Intended for test purposes only.

### 1.2.12 TP1 – IN

Input voltage test point.

### 1.2.13 TP2 – OUT

Regulated output voltage test point.

### 1.2.14 TP3 – GND

Ground test point.

**1.2.15 TP4 – GND**

Ground test point.

**1.2.16 TP5 – GND**

Ground test point.

**1.2.17 TP6 – SO**

Bode plot measurement test point.

**1.2.18 TP7 – PG**

Bode plot measurement test point.

**1.3 Soldering Guidelines**

To avoid damaging the integrated circuit (IC), use a hot-air system for any solder rework to modify the EVM for the purpose of repair or other application reasons.


**1.4 Equipment Connection**

Connect the equipment as shown in the following steps:


1. Set the input power supply up to 40 V (max), and turn them off.
2. Connect the positive voltage lead from the input power supply to VIN at the J3 connector of the EVM.
3. Connect the ground lead from the input power supply to GND at the J8 connector of the EVM.
4. Connect a 0-A to 150-mA load between VOUT and GND.
5. Disable output voltage by connecting J6 pin 2 (EN) to J6 pin 1 (GND).

**Figure 3. Top Layer Routing**




Figure 4. First Middle Layer




Figure 5. Second Middle Layer




Figure 6. Bottom Layer Routing

For clarification, any software or software tools provided with the EVM ("Software") shall not be subject to the terms and conditions set forth herein but rather shall be subject to the applicable terms that accompany such Software
  - 1.2 EVMs are not intended for consumer or household use. EVMs may not be sold, sublicensed, leased, rented, loaned, assigned, or otherwise distributed for commercial purposes by Users, in whole or in part, or used in any finished product or production system.
2. *Limited Warranty and Related Remedies/Disclaimers:*
  - 2.1 These terms do not apply to Software. The warranty, if any, for Software is covered in the applicable Software License Agreement.
  - 2.2 TI warrants that the TI EVM will conform to TI's published specifications for ninety (90) days after the date TI delivers such EVM to User. Notwithstanding the foregoing, TI shall not be liable for a nonconforming EVM if (a) the nonconformity was caused by neglect, misuse or mistreatment by an entity other than TI, including improper installation or testing, or for any EVMs that have been altered or modified in any way by an entity other than TI, (b) the nonconformity resulted from User's design, specifications or instructions for such EVMs or improper system design, or (c) User has not paid on time.
